

# Eklektizismus

Als **Eklektizismus** (von griech. ἐκλεκτός, *eklektos*, „ausgewählt“) bezeichnet man Methoden, die sich verschiedener entwickelter und abgeschlossener Systeme (z. B. Stile, Philosophien) bedienen und deren Elemente neu zusammensetzen. Im Falle von Religionen spricht man jedoch eher von Synkretismus als von Eklektizismus.

## Eklektizismus in der Kunst

Der Eklektizismus ist kennzeichnend für die Stilrichtungen der europäischen Kunst seit Beginn des Historismus. Als Kunstverfahren ist Eklektizismus in der Postmoderne für die kritische Reflexion über vorhandenes Material von Bedeutung.

Die Bezeichnung *eklektisch* oder *eklektizistisch* bezieht sich auf ein einzelnes Kunstwerk, in dem verschiedene vergangene Stile verarbeitet sind.<sup>[1]</sup>

Im Hinblick auf die jeweilige künstlerische Qualität ist zwischen Imitation und eigener Weiterentwicklung zu unterscheiden. Der Begriff kann mit einer negativen Betonung versehen sein, wenn der Künstler anstelle einer eigenen Kreation unschöpferisch Elemente aus anderen Werken auswählt und zu einem neuen Werk zusammenfügt.

## Eklektizismus in der Philosophie

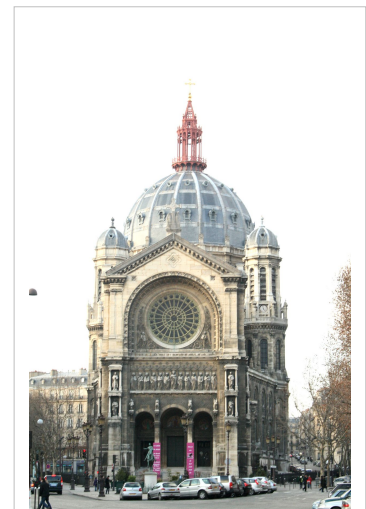
Der Begriff ist bereits in der Antike, etwa zur Zeitenwende, geprägt worden. Damals existierten verschiedene Philosophenschulen nebeneinander und es gab Denker und Politiker, die als Eklektiker bezeichnet wurden, weil sie Elemente der unterschiedlichen Positionen miteinander verbanden. Der berühmteste Vertreter dieser Richtung war Cicero. Er übernahm besonders in seinen ethischen Vorstellungen im Wesentlichen die Lehren der Stoiker, wobei er auch Werte der Akademie und des Peripatos einfließen ließ.

## Eklektizismus in der Geisteswissenschaft

In den Geisteswissenschaften charakterisiert der Begriff die Methode, aus Versatzstücken unterschiedlicher Systeme, Theorien oder Weltanschauungen eine neue Einheit zu bilden. Auch hier wird der Terminus in der Regel abwertend verwendet. Dies verrät eine Bevorzugung in sich abgeschlossener, isolierter Theorien gegenüber der Selektion zutreffender Aussagen aus verschiedenen Theorien bei Nichtübernahme widerlegter Elemente.

## 0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially.
